- Applicants must be a “qualified donee” as defined under the Income Tax Act – see CRA website
- As of September 2016, the board of directors has set a goal to distribute \$120,000
- Grant application **deadline is September 30, 2016. Send to esorochan@banffcanmorecf.org**
- Granting decisions are made by November 2016
- Successful applicants will receive funds in December 2016 and have 12 months to complete project

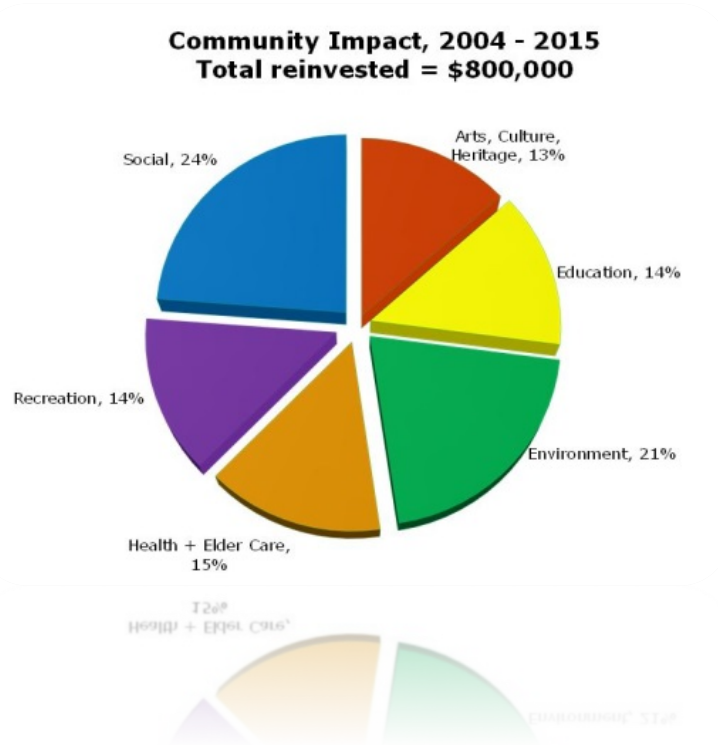

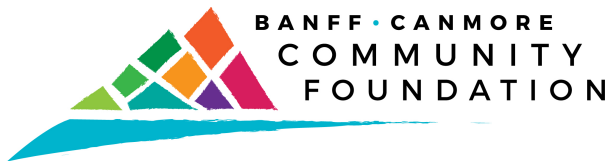
5.6 Grants are not made towards operating costs or capital deficits

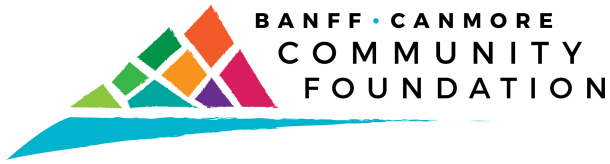
